SECTION 3 - CATEGORIES OF PERSONAL DATA, AIMS 'AND LEGAL BASIS

to. Categories of personal data

Among the personal data Promhotel SRL - HOTEL ORIENTALE These include:

- contact details, such as name, postal address, email address and telephone number;
- number of credit card number or other payment account, billing address and other details concerning payment and invoicing; User registrations and copies of correspondence if she contacts the hotel;
- data needed to fulfill special requests (eg, health conditions that require a specific arrangement); User data on trips, including hotel where he spent the night, date of arrival and departure and purchased goods and services; data collected through the use of systems of closed circuit television cameras, electronic keys and other security systems; in limited cases, information relating to customer credit.

The data may be collected in the following ways:

- directly by the interested party;
- via the website for reservations or inquiries; by third parties through the outer channels of booking (Booking and others); via social media.

b. Purpose 'of treatment (art. 13, paragraph 1c)

Promhotel SRL - HOTEL ORIENTALE will process your personal data only in the presence of a specific legal basis provided for by the applicable laws on privacy and protection of personal data, for the following purposes:

- replying to its eventual contact request, with sending information from her requests;
- for sending commercial communications and information about events organized hotel through newsletters and institutional communications.

c. Legal Base of treatment - (Art. 13 paragraph 1d call art. 6 paragraph 1f)

The legal basis used by Promhotel SRL - HOTEL ORIENTALE to treat your personal data, according to the purposes indicated in the preceding paragraph, are the following:

1. Provision of services and contractual obligations and pre

The provision of your personal data is necessary to provide the services requested and execute contracts (including acts in the pre-contractual phase) is not mandatory by law, but the refusal to provide such data will make it impossible for Promhotel SRL - HOTEL ORIENTALE to comply with what you requested.

2. Legitimate interest of the Holder

The processing of your personal data is necessary to pursue a legitimate interest, namely:
to fulfill contractual obligations arising from the sale of services; to check the after sales service aimed at improving the quality of service.

3. Legal obligations which Promhotel SRL - HOTEL ORIENTALE is subject

The processing of your personal information to comply with regulatory requirements is required and, therefore, for this reason it is required your consent.

SECTION 4 - CATEGORIES OF RECIPIENTS TO WHOM YOUR DATA MAY BE DISCLOSED

To achieve the above mentioned purposes it may be necessary that Promhotel SRL - HOTEL ORIENTALE communicate your personal data to the following target groups:

- Third party suppliers of services to meet additional requirements than those offered by the Hotel; Third parties (authorities, companies, professional firms, consultants, etc.) who process personal data in the context of:
the Authority for mandatory reports required by law (Police of Brindisi and National Electronic Center of the State Police); to the external managers for the fulfillment of legal obligations; Interchange System.

SECTION 5 - DATA TRANSFER TO A THIRD COUNTRY - (Art. 13 para 1f)

His Personal Data are processed by Promhotel SRL - HOTEL ORIENTALE within the European Union and shall not be released.

Profiling and Dissemination of data - (Art. 13 para 2f)

Your personal data are not subject to disclosure or to any fully automated decision-making process, including the profiling.

SECTION 6 - METHOD 'TREATMENT AND PERIOD OF RETENTION OF PERSONAL DATA - (Art. 13 para 2a)

The processing of your Personal Data are processed using manual, computer and data, and to ensure the security and confidentiality of the data. In general, your personal data shall be kept for a time period of 10 years from the closing of the contract of which you are part of and, subsequently, for the time needed for other purposes, provided for by law or REGULATION .

SECTION 7 - RIGHTS - (Art. Various)

Among the rights recognized by Regulation 2016/679 include those of:

- request access to your personal data and information relating to them (Art. 13 para 2b); the correction of inaccurate data or the integration of those incomplete (Art. 13 paragraph 2b);
- deletion of personal data concerning the occurrence of one of the conditions indicated in the art. 17, paragraph 1 of the REGULATION and in accordance with the exceptions in paragraph 3 of the same article (Art. 13 paragraph 2b);
- the limitation of the processing of personal data (upon the occurrence of one of the assumptions indicated in art. 18, paragraph 1 of REGULATION 2016/679) (art. 13 paragraph 2b); request and obtain, in cases where the legal basis of the treatment is the contract or consent, and the same is carried out by automated means, your personal data in a structured format and readable by an automatic device, also in order to communicate such data to another data controller (art. 20 Right to the portability of personal data);
- object at any time to the processing of your personal data on the occurrence of particular situations concerning you (Art. 21 Right of opposition); revoke your consent at any time, limited to cases in which the treatment is based on your consent for one or more specific purposes and concerns common personal data (such as date and place of birth or place of residence), or special categories of data (for example, data that reveal your racial origin, political opinions, His religious convictions, state of health or sex life). The treatment based on consensus and carried out prior to the withdrawal of the same, still retains, its legitimacy (art. 7);
